  - (E) Explain how you arrived at the above figures for (A) through (C) and whether an event like the proposed one was held previously. If it was state the date and the number of persons who attended that event.
  
7. Provide a brief description of the property where the event is to be held including its size. If possible include a sketch or map of the area that is going to be used. Also state how the property will be accessed for those attending the event.
  
8. How do you anticipate most people will travel to the event?

9. State the number of parking spaces are you providing and their location. If possible include a sketch or map of the area that is going to be used. If you are relying upon on street parking identify the streets where this will occur.
  
10. Provide a description of how and where this event is being advertised.
  
11. Will food or beverages be sold at the event? If so what kinds.
