Old Business

Oppose S3094/A4305 – Contractors doing public work with apprenticeship programs. Hughes reported the Assembly has approved the changes of the Senate; and this is now to go for a full Assembly vote. Motion by Hughes, seconded by D'Angeli, to oppose A4305 adopt the following resolution:

WHEREAS, the Township Committee of the Township of Lafayette has determined that Assembly Bill A-4305 (companion bill to Senate Bill S-3094) requires contractors who bid on public works contracts to have an apprenticeship program in place; and

WHEREAS, Assembly Bill A-4305 will, also, be unfair to the local contractor wanting to bid on a public works contract; and

WHEREAS, Assembly Bill A-4305 will, also, increase the cost of the public works projects which the taxpayer will need to fund, which is against the State recommendation of lowering municipal taxes.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Lafayette, County of Sussex, State of New Jersey, does hereby oppose Assembly Bill A-4305 as it will place an undue financial hardship on New Jersey municipalities.

- 3. Any and all portions of any and all ordinance that may be inconsistent with the provision of this ordinance are hereby rescinded.

Oppose A4151 - Hughes reported A4151 would extend prevailing wage requirements to food services, public bodies and schools. The Office of Legislative Services has shown the local cost estimates to be very significant, which is opposite of the State saying local costs need to be reduced.

Motion by Hughes, seconded by D'Angeli, to oppose A4151 that would extend services of prevailing wage to food services, public bodies and schools as this would add significant costs as shown by the Office of Legislative Services and adopt the following resolution:

Audience

<u>David Decker</u>, Fire Department Chief, said two (2) students have graduated from fire school; and they only need one (1) set of turnout gear. He said the approximate cost is \$2,500.00.

Motion by D'Angeli, seconded by Hughes, to introduce the following ordinance and set the public hearing date of January 19, 2010:

AN ORDINANCE OF THE TOWNSHIP OF LAFAYETTE, COUNTY OF SUSSEX, NEW JERSEY, PROVIDING FOR THE ACQUISITION OF ONE (1) SET OF TURNOUT GEAR AND RELATED APPURTENANCES AND APPROPRIATING \$2,500.00 FROM THE RESERVE FOR THE FIRE DEPARTMENT IN THE CAPITAL FUND FOR SUCH PURPOSE

BE IT ORDAINED by the Township Committee of the Township of Lafayette, County of Sussex, New Jersey, as follows:

Section 1. The funding for the Acquisition of one (1) set of turnout gear and related Appurtenances is hereby authorized and the cost is not to exceed \$2,500.00 which sum is hereby appropriated for such purposes.

Section 2. The total amount of \$2,500.00 is hereby appropriated from the Reserve for the Fire Department available in the Capital Fund.

Section 3. This Ordinance shall take effect upon publication of notice of final adoption as provided by law.

Motion carried by roll call vote: Hughes-yes, Corcoran-yes, D'Angeli-yes, Sweeney-yes, Bruning-yes.

Mr. Decker asked for the Fire Department's portion of the Township budget. Mayor Bruning suggested he call the CFO and said this is not to be a part of their own budget.

<u>James Ando</u>, Road Department, asked that the Road Department receive more than a \$.25 per hour raise. Mayor Bruning explained the increase was based on the cost of living, which is less than one (1%) percent. He said the Township Committee cannot justify more to the taxpayers due to the economy.

<u>Frank LoPorto</u>, Road Department, said the cost of living adjustment for his child support was four (4%) percent in 2009. Mayor Bruning noted employers are not responsible for personal finances.

Committeeman Hughes said the one and a half (1.5%) percent raise was based on the current Township financial constraints. They are anticipating a ten (10%) percent increase in health costs; and the Township will continue to pay the health insurance.

Committeeman Hughes said the Township Committee values everyone's job and performance.
