AUTHORIZATION FOR THE FREEHOLDER DIRECTOR AND THE CLERK OF THE BOARD TO EXECUTE MUNICIPAL ALLIANCE BUDGET MODIFICATION ALLOCATING AN ADDITIONAL \$2,700.00 TO THE CENTRAL MUNICIPAL ALLIANCE FOR THE PROVISION OF ADDITIONAL SUBSTANCE ABUSE PREVENTION PROGRAM FUNDING

WHEREAS, the Sussex County Board of Chosen Freeholders authorized an Agreement with the Borough of Branchville, Township of Frankford and Township of Lafayette on September 9, 2015 covering the period July 1, 2015 through June 30, 2016 to provide substance abuse prevention programs for the residents of Sussex County; and

WHEREAS, funding for this Agreement was set at \$9,958.00 has been appropriated in the 2015 County budget; and

WHEREAS, the Central Municipal Alliance requested an additional \$2,700.00 to be used to increase the budget for three of their substance abuse prevention programs; to wit, "Community Asset Building", "Project PRIDE", and "Peer to Peer"; and

WHEREAS, there exists funding within the Countywide Alliance Budget to grant such requests pursuant to a Budget Modification process approved by the Governor's Council on Alcoholism and Drug Abuse (GCADA); and

WHEREAS, said Budget Modification has been approved by the County Alliance Steering Subcommittee and GCADA.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Lafayette approves the allocation of an additional \$2,700.00 which raises the total to \$12,658.00 to the Central Municipal Alliance for the provision of substance abuse prevention services; and

BE IT FURTHER RESOLVED that the Freeholder Director and Clerk of the Board of Chosen Freeholders are authorized to execute the Agreement for these services; and

BE IT FURTHER RESOLVED that certified copies of this Resolution and Agreement be forwarded to Sharon M. Yarosz, Central Municipal Alliance, Township of Frankford Municipal Building, 151 Route 206, Augusta, NJ 07822.

Audience

Mr. Wilfred Jiroux, III, 43 Pelletown Road Mr. Wilfred Jiroux, 175 Statesville Quarry Road

Mr. Jiroux, III asked that the Township reconsider paving Pelletown Road because of the speeders and people passing on the double lines. He feels the Township should go back to oil and stone. Mr. Jiroux, III, also, said there is a lot of truck traffic on the road; and weight limit signs are needed.

Mr. Jiroux said he spoke with the NJ Department of Transportation (NJDOT) about speed limits and was told they do not handle local road speed limits. He suggested the installation of speed tables/bumps to slow people down. Mr. Jiroux, III suggested making Pelletown Road one-way.

Mr. Jiroux said "Maggio" trucks are constantly on Pelletown Road and are speeding. They are using large trucks. He said the traffic is out of control and the Township should use oil and stone to slow vehicles down.

Mr. Jiroux feels the zoning ordinances need to be enforced. He said there are too many trucks on the residential roads and people are operating illegal businesses from their homes. Mayor Henderson asked if he spoke to the Zoning Officer. Mr. Jiroux said he has not.

Mr. Jiroux said he is partnering with Mr. Todd Deming to make wildlife jewelry; and the sign was taken by the Zoning Officer. He feels this addition to his business is legal.

Committeeman Corcoran suggested Mr. Jiroux talk to the Zoning Officer and give him specifics so he can inspect.

Mr. Jiroux asked about the "Pumleye" property on Route 15 becoming a parking lot. Committeeman Hughes explained the NJ Department of Environmental Protection (NJDEP) will not allow a paved parking area. Mr. Jiroux said this should not be a problem because of a new paved parking area being done at a building near the traffic light; and the brook flows through their back yard.

Mr. Jiroux feel the Township needs a vision for improvements and to move forward. The Township needs more ratables to help with the taxes.

Mr. Jiroux, III asked why a trail is being proposed for the "Lawler" property. Mayor Henderson said the property is leased to a farmer; and the trail will be well maintained.

Mr. Jiroux said the Olde Lafayette Village is a mess; and the Township should do something about it.

Adjourn
