**STAVOLA BEAVER RUN QUARRY, LLC  
EXTENSION OF QUARRY PERMIT  
THE PROPERTY (Block & Lots listed herein)**

**WHEREAS, Shotmeyer Bros. Co., LP**, a New Jersey limited partnership, and **Lawrence Koster, Inc.** (collectively the “Owners”) and **Beaver Run Farms Quarry LLC** (as “Developer”), pursuant to a Developers Agreement dated March 16, 2015, posted a Restoration Bond with the Township of Lafayette; and

**WHEREAS**, the issued Bond in favor of the **Township of Lafayette** (“the Township”) is designated Bond #13BCSHK8608; and

**WHEREAS**, the Property is identified on a plan entitled “2021-2028 Quarry Permitting Plan, Stavola Beaver Run Quarry, Block 27, Lots 1, 2, 3, 4.01, 4.02; Block 28, Lots 2.01, 2.02, 3, 4, 5 (now or formerly Lot 5 & Lot 1), and 7; and Block 29, Lot 2 as depicted on the Tax Map of Lafayette Township, and excluding those lots in the Township of Hardyston, prepared by Dykstra Walker Engineers dated November 17, 2021 and last revised May 13, 2022, and was conveyed to **STAVOLA BEAVER RUN QUARRY LLC** (“Stavola”); and

**WHEREAS**, Stavola submitted an application to the Township to request a seven (7) year extension of the Quarry Permit (the “Permit”) retroactive to March 16, 2022, to terminate on March 30, 2029, to allow the operation of the Quarry, subject to the execution of a new Developers Agreement and the posting of an in-force Restoration Bond in the amounts set forth in the Developers Agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Lafayette Township Committee that upon the delivery to the Township and the written approval of the Township attorney of an in-force Restoration Bond in the amounts set forth in the Developers Agreement, the current in-force Bond #13BCSHK8608 shall be released and discharged.
